2. DURING MEETING JULY 13 WITH FONMIN KHADDAM, I INFORMED HIM OF PRESIDENT'S WILLINGNESS TO MEET WITH HIM AND PRINCE SAUD ON THURSDAY, JULY 15, AT 3:30 P.M. KHADDAM EXPRESSED HIS PLEASURE AT PROSPECT OF MEETING WITH THE PRESIDENT AND SAID HE LOOKED FORWARD TO IT&
3. KHADDAM SAID THAT HE HAD ALREADY BEEN IN TOUCH WITH SAUD ON THE DATE OF THE MEETING AND SAUD HAD INFORMED HIM THAT HE, SAUD, WANTED TO POSTPONE THE MEETING UNTIL FRIDAY, THE 16TH, OR MONDAY, JULY 19. KHADDAM SAID THAT HE HAD INFORMED SAUD THAT WHITE HOUSE HAD FIXED THE DATE AND IT WAS UP TO THE SAUDIS TO REVISE IT IF THEY FELT IT NECESSARY.
4. AS FOR KHADDAM, HE SAID THAT HE COULD BE IN WASHINGTON IN TIME FOR THE JULY 15 MEETING BUT THAT IF SAUD WISHED TO POSTPONE IT TO A LATER DATE, KHADDAM WOULD ADJUST HIS SCHEDULE ACCORDINGLY. HE SPECULATED THAT PERHAPS THE SAUDIS WISHED A POSTPONEMENT BECAUSE OF THE CALL FOR AN ARAB LEAGUE SUMMIT TO BE HELD IN TUNIS ON JULY 15 BUT HE WAS NOT SURE THAT THIS WAS THE CASE. KHADDAM ASKED ONLY THAT THE MEETING NOT BE RESCHEDULED DURING THE 'ID WHICH BEGINS ON APPROXIMATELY JULY 21 OR 22.
4. KHADDAM REQUESTED THAT WE CONTACT AMBASSADOR MURPHY TO SEE IF HE COULD FIX THE DATE FOR THE MEETING WITH SAUD ASAP SINCE IF THE MEETING IS TO TAKE PLACE ON JULY 15, KHADDAM WILL HAVE TO LEAVE ALMOST IMMEDIATELY. HE ASKED ME TO GET BACK WITH HIM BY NOON OUR TIME TODAY, JULY 13. PLEASE ADVISE.




