(TEXT) BEIRUT, 17 APR (QNA) -- LEBANESE SECURITY FORCES THIS MORNING FOUND THE CORPSES OF THREE BRITONS WHO WERE KIDNAPPED IN BEIRUT EARLIER. SECURITY SOURCES TIPPED THE CORPSES TO BE THOSE OF ALLEC COLLETT, PHILIP PATFIELD, AND LEIGH DOUGLAS.

AN UNIDENTIFIED PERSON WHO SAID HE IS TALKING IN THE NAME OF THE ISLAMIC JIHAD ORGANIZATION INFORMED SOME LOCAL RADIOS THIS MORNING THAT THE ORGANIZATION EXECUTED THE KIDNAPPED BRITONS. IT IS EXPECTED THAT EXECUTION WILL BE CARRIED AGAINST SOME KIDNAPPED AMERICANS IN LEBANON IN REPLY TO THE U.S. ATTACK ON LIBYA.

ACCORDING TO LEBANESE RADIO STATIONS, AT LEAST 27 SYRIAN CADETS KILLED AND MANY OTHERS INJURED IN SEVEN TERRORIST BOMB EXPLOSIONS ACROSS COASTAL SYRIA TODAY. NO IMMEDIATE GOS COMMENT. CONNECTION TO LIBYAN EVENTS UNLIKELY.

KIDNAPPED OVER ONE YEAR AGO. THE STATEMENT DECLARED: "WE ANNOUNCE THE SENTENCE OF DEATH FOR THE BRITISH SPY ALEC COLLETT, TO BE EXECUTED DURING A POPULAR CEREMONY TO PUNISH THE CRIMINAL THATCHER AND HER FOREIGN MINISTER HOWE AND HER REACTIONARY AUTHORITY WHICH HAS TRANSFORMED HER COUNTRY INTO AN AMERICAN COLONY." THE SAME GROU ALSO "INVITED ALL ORGANIZATIONS THAT HOLD AMERICAN AND BRITISH HOSTAGES TO EXECUTE THEM, AS SPILLING THE BLOOD OF AMERICANS OR BRITONS WHEREVER THEY ARE FOUND HAS BECOME LEGITIMATE AFTER THE CRIMINAL ACTS PERPETRATED BY THE CRIMINALS REAGAN AND THATCHER." THE GROUP ALSO ANNOUNCED THE "NEUTRALIZATION OF EUROPE" IN THE BATTLE WAGED AGAINST U.S. AND BRITISH FORCES. ACCORDING TO THE COMMUNIQUE, COLLETT WAS HANGED BEFORE BEING SHOT.

2. ANOTHER COMMUNIQUE, SIGNED BY "THE ARAB FEDAYEEN CELLS" SAID:

"IN RESPONSE TO THE ATTACK OF THE NAZI REAGAN AGAINST THE ARAB PEOPLE OF LIBYA, LAUNCHED WITH THE SUPPORT OF THE BRITISH GOVERNMENT, WE HAVE EXECUTED AN OFFICIAL OF THE CIA AND TWO BRITISH INTELLIGENCE OFFICERS. THIS EXECUTION ILLUSTRATES THE REVOLUTIONARY POSITION OF THE ARAB FEDAYEEN CELLS IN THE DEFENSE OF OUR ARAB NATION AND OF OUR ARAB SOIL, WHICH WAS VIOLATED BY THE IMPERIALIST, ZIONIST, AND REACTIONARY ENEMIES. IT IS A RESPONSE TO THE NEO-NAZI AND TO THE INTERNATIONAL TERRORIST REAGAN WHO COMMITTED AGGRESSION AGAINST OUR LIBYAN ARAB PEOPLE, COMMANDED BY THE MILITANT CHIEF MUAMMAR QADHAFI. INTERESTS ARE OUR TARGETS. WE WILL NOT CEASE BEFORE PURGING OUR NATION OF THESE ZIONIST IMPERIALISTS ANJUWE WILL TRACK THEM DOWN EVERYWHERE."

3. WALID JUMBLATT, PSP LEADER, SPOKE OUT AGAINST THE TERRORISTS. AFTER NOTING THAT HE HAD DENOUNCED THE U. S. RAID AGAINST LIBYA, HE SAID THAT HE COULD NOT REMAIN QUIET ABOUT CRIMES COMMITTED IN THE NAME OF NATIONALISM, ARABISM, OR ISLAM. "I CANNOT REMAIN QUIET WHEN CONFRONTED BY ACTS PERPETRATED BY MERCENARIES FOR A FEW DOLLARS. I PERSONALLY ANUME THE RESPONSIBILITY FOR MY WORDS, BECAUSE I SEE THAT MY COUNTRY IS GOING DOWN THE DRAIN AND THAT WEST BEIRUT IS NOW JUST ABOUT A JUNGLE."
