THE GROUP WAS [REDACTED] DISCUSSING THREE RECENT ACTS OF VIOLENCE WHICH HAD OCCURRED IN CHILE: THE KILLING OF THE ROJAS BOY, THE ASSASSINATION ATTEMPT AGAINST PINOCHET, AND THE SHOOTING OF A JOURNALIST. COMMENTS WERE MADE ABOUT THE AMOUNT OF ATTENTION THAT EACH ACT GENERATED IN THE CHILEAN AND INTERNATIONAL PRESS, AND THE FACT THAT THE GREATEST AMOUNT OF PRESS PLAY WOULD BE GENERATED IF THE VICTIM OF THE TERRORIST ACT WERE AN AMERICAN CITIZEN.
