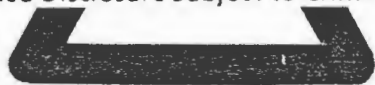

Attached at Tab I is the critique of the British analysis which I repackaged per your instructions. At Tab II is a sanitized version of CIA's analysis of the Hizballah. I had included the jist of these judgments in my critique of the British paper. The paper at Tab III is not cleared for release to the UK. The British analysis is returned at Tab IV.
