Dear Powell,

As you may know, the Task Force Working Group is in the research and analysis phase of our effort. The purpose of this portion is to identify the baseline for national policies, management mechanisms, capabilities, and related programs.

As a follow-up to our very fine session with Major General "Duff" Rice on 9 September, I would appreciate your assistance in arranging two additional events for the Working Group. First, we would like to interview the Commander, Counterterrorist Joint Task Force (CTJTF) in order to gain a clear understanding of this key military capability. If feasible, we would prefer to conduct this interview at 730 Jackson Place, N.W., Washington, D. C., within the next couple of weeks.

Second, I understand the CTJTF will be conducting two capabilities exercises at Ft. Bragg next month for purposes of demonstrating counterterrorism skills and tactics. I believe it would be beneficial for the Working Group to observe the CAPEX on 23 October if that can be arranged. I have attached a list of those Working Group members who would be attending.
