SUBJECT: Schedule Proposal for National Security Planning Group (NSPG) Meetings on Counter-Terrorism

Attached at Tabs I and II are memos from Bill Martin to Fred Ryan requesting that two NSPG meetings on counter-terrorism be scheduled. The first meeting (Tab I) proposed for December 20, 1985 from 11:00 a.m.-12:00 noon in the White House Situation Room (WHSR) would be used for a final review of the findings/recommendations proffered by the VP's Task Force on Combatting Terrorism. Absent changes arising from this NSPG meeting, the TF report will be submitted to the President that same day.

The second NSPG meeting (Tab II) proposed for January 7, 1986 will consider a draft National Security Decision Directive (NSDD) implementing the TF recommendations approved at the December 20, NSPG. This NSDD will be drafted while the President is in California for the Christmas holidays.

Please note that the first of these two meetings is referenced in the Pearson/Poindexter memo at Tab III. If you approve the request for the second meeting on January 7, we will reschedule the Central American policy review NSC meeting currently planned for that date to January 10. This shift is necessitated by ADM Holloway's departure for Europe on January 8.

Don Greg and Bob Pearson concur.
