SUGGESTED TALKING POINTS FOR MEETING WITH  
SENATE MAJORITY LEADER HOWARD BAKER AND  
SENATE ENERGY COMMITTEE CHAIRMAN JIM McCLURE

- Indicate your support for maintaining nuclear power as a source of energy for our nation's electric utilities.
- Acknowledge the difficult task that lies ahead of us in restoring public confidence in nuclear power and in repairing the damage done by the previous Administration's efforts to undermine nuclear power.
- Indicate that you believe that there are three critical steps we must take to keep the nuclear option alive:
  - (1) We must restore regulatory certainty to the industry with a Nuclear Regulatory Commission that is willing to make hard choices, including issuing licenses for the complete power plants now sitting idle; and licensing reprocessing plants;
  - (2) We must implement the economic recovery plan so that long-term interest rates will come back down to reasonable levels, permitting utilities to finance new powerplants;
  - (3) We must demonstrate our commitment to the future of nuclear power by moving ahead with the Clinch River Breeder Reactor project.
- Indicate your concern that we must maintain the largest possible degree of private industry participation in nuclear power, that Federal government should not be getting any deeper into the utility business.

-- Thank meeting participants, and request their cooperation in developing a sound new Federal policy toward nuclear power.

PURPOSE: To present you with a season pass to all major league baseball games for the 1981 season. Additionally, Commissioner Kuhn may invite you to throw out the season's first ball at one of the league openers: The National League game on April 8th in Cincinnati (Reds vs. Phillies) or one of the American League games on April 9th. You may want to indicate that while you would welcome the chance to participate in this traditional ceremony, your involvement will depend on your schedule.

BACKGROUND: It is customary for the President to receive a season pass. Additionally, Presidents often accept the invitation to throw out the first ball. Major league baseball has enjoyed a period of renewed growth of late, although the possibility of a players' strike over the issue of compensation to clubs for losses in the free agent draft may delay the season's opening.

SUGGESTED TALKING POINTS FOR MEETING WITH

Bowie Kuhn, Baseball Commissioner

- Commissioner Kuhn will probably invite you to throw out the first ball at one of the opening games: April 8 in Cincinnati (Reds vs. Phillies) for the National League or April 9 for one of several American League openers. You may wish to tell Bowie that you would like to participate in this traditional ceremony, but it will depend on your schedule and your staff will get back to him.
  
- You may wish to ask Bowie's prognosis on how well the California Angels (owner: Gene Autry), Los Angeles Dodgers (owner: Peter O'Malley) and the San Diego Padres (owner: Ray Kroc) will fare this season.
  
- There is a possibility of a players' strike which might prevent the scheduled opening of the season. Bowie will probably say the players and owners are negotiating, and he is hopeful a strike can be avoided. He prefers discussion rather than confrontation. The labor issue concerns compensation to clubs which lose players in the free agent draft. The owners want compensation; the players' union opposes such.

I. PURPOSE

To reiterate appreciation for the early and aggressive support for the President's candidacy and election by these fourteen Republican Members of the House and to ask for their support in the months ahead on the economic program.
