## LARRY SPEAKES IN Q&A WITH REPORTERS OUTSIDE THE SOVIET MISSION

MR. SPEAKES: Yes, the two sides have agreed to recess momentarily while their -- and the United State delegation has returned to the U.S. Mission to receive a briefing from those who have been working on possible agreements, possible ideas about how we report on the meeting.

The Soviet delegation and the U.S. delegation have been meeting at the U.S. Mission. They will return -- the Soviets will return to this Mission and report to their ministers and the U.S. delegation went there to receive the information.

Q The Soviets went to their -- the Soviets stayed here for their briefing with their people? Is that what you are saying?

MR. SPEAKES: Here's the scenario. The U.S. and the Soviets were meeting at their -- at the U.S. Embassy -- a group outside of this meeting. They have agreed -- the two leaders have agreed to -- the two leaders agreed in the meeting that they would confer with those who had been holding a separate meeting. So the Soviets are returning to their Mission to confer with their delegation and the U.S. group is going to the U.S. Mission to confer with its delegation.

Meanwhile the President and the General Secretary remain here in a private conference. It's in a stand-up fashion in the large hall of the Mission here.

- Q When did it break up and how long did it go on?
- MR. SPEAKES: If I can give you the times here.
- Q Can you get this back to our office, because we don't have a phone.
- MR. SPEAKES: We need to work out a way for you to phone it some way.

What we've got is a -- We arrived here at 2:25 p.m. The General Secretary suggested that the two go into a private session, which they began at 2:29 p.m. It lasted for fourteen minutes. At 2:43 p.m. they began the session with the large group and at 3:30 p.m. they recessed.

Q How long did it last? Only fourteen minutes.

MR. SPEAKES: Fourteen minutes for the private session and the other one lasted from 2:43 p.m. until 3:30 p.m., so roughly fifty minutes there give or take a few.

Q How long to you expect this recess to be?

MR. SPEAKES: The recess is scheduled to last about 30 or 40 minutes. I think our group will be back here at 4:15 p.m.

Q All right. And then, what's the situation as far as the time tomorrow? Has that been worked out? Do you know what time this thing's going to take place and where?

MR. SPEAKES: Well, what is under discussion now is to -whether and how we will report the occurrences at the summit. There
have been discussions that have been ongoing, both in the meetings
with the principals, and outside of the meetings with the principals.
And the point is, we've reached a point where they would like to
confer with their subordinates, and they have gone out to do so.

Now, at the moment, no decisions have been made regarding how the two leaders will report.

 $\ensuremath{\mathtt{Q}}$  Do you know who has been heading the U.S. effort in this regard outside of these meetings?

MR. SPEAKES: It's been a number of people from Defense, State and NSC.

Q But they've all been meeting at the U.S. Mission. Now, each side is going to their own mission --

Q Is this an indication that the blackout is lifted?

MR. SPEAKES: No, the Soviets and the Soviet spokesman, Mr. Zamyatin, and I agreed inside just a few minutes ago that I would come out and make the report and we would like to have this filed so that all can get it.

Q Larry, how big were the delegations that were meeting apart from the principles?

- MR. SPEAKES: I think all of those questions are topics for discussion. There have been the ongoing talks between the Secretary General and the President and then these talks at a second level. It's time now to bring both talks together and to discuss all aspects of the summit.

Q Now, this -- if there are any agreements, this is the point at which they would come back from the officials who've been working on the details and would be presented to the leaders for their approval?

MR. SPEAKES: Well, I can't predict. This is for a moment -- an opportunity for both sides to confer with their respective delegations.

Q Did we come in with a plan at all?

MR. SPEAKES: I just don't really want to go beyond that. I think this is about all we've agreed to do.

Q Is this to indicate that there were no deals being cut in here by the leaders and they were all outside this conference?
