## **Biography**

### **Biography**

Born Robert Michael Kimmitt in Logan, Utah in 1947, Kimmitt went on to graduate from

West Point US Military Academy in 1969. He served with the 173rd Airborne Brigade in Vietnam from 1970-1971 and was then assigned to 101st Airborne Division at Fort Campbell, Kentucky from 1972-1974. From 1974-1977, he attended Georgetown Law School on an Army scholarship, during which he was assigned as a legislative counsel to the Army's Chief of Legislative Liaison (summer 1975) and then as an NSC Staff member specializing in arms sales under Presidents Ford and Carter (1976-1977).

After graduation from law school, Kimmitt served as a law clerk to Judge Edward A. Tamm of the US Court of Appeals for the DC Circuit (1977-1978). He returned to the NSC staff in 1978, serving as NSC legal counsel and arms sales policy officer under Carter and Reagan. In early 1982, Major Kimmitt left active military service to assume the civilian positions of NSC General Counsel and Director of Legislative Affairs and Security Assistance. He was awarded the Defense Superior Service Medal for his work at the NSC, including his responsibilities on the intelligence charter legislation which resulted in Executive Order 12333 and his leadership in the interagency review of executive branch classification procedures which resulted in EO 12356. In 1983, Kimmitt was appointed to the positions of Executive Secretary of the NSC and Deputy Assistant to the President for National Security Affairs. He also retained his previous designation as General Counsel to the NSC. As Executive Security of the NSC, he directed a staff of 150 individuals in support of the President and his Assistant for National Security Affairs.

From 1985-1987, Kimmitt served as General Counsel to the US Department of Treasury. Then in 1989, he was appointed as Under Secretary of State for Political Affairs. In 1991-1993, George H. W. Bush appointed Kimmitt as the US Ambassador to Germany. After leaving the State Department, Ambassador Kimmitt then went on to serve as a member of the Director of Central Intelligence's National Security Advisory Panel from 1998-2005.

### **Scope and Content**

Kimmitt's various NSC offices were not separated into different collections. All files but those representing his Executive Secretary functions are in this collection. The functions are easily identifiable by Legal, AT (Arms Transfer), LA (Legislative) tags. Please see the records of the [NSC Executive Secretary](#) for his work in that office.
