This collection consists of the National Security Council's (NSC) Executive Secretariat's centralized material on National Security Decision Directives (NSDDs) enacted during the Reagan Administration. Material on specific NSDDs often consists of draft versions, action plans, and background memos in addition to copies of the various NSDDs. This collection is partially open for research and the open folders are noted.

Since the NSC has declassified in full and in part many of these NSDDs, the Library maintains a reference file copy of these declassified and partially declassified NSDDS for quick reference. There is a paper copy in the Library Research Room and a <u>digitized</u> copy on this site.
