Biography

Melvin Leroy Bradley was born on January 6, 1938 in Texarkana, Texas. He spent his youth in Texas and graduated from local Dunbar High School in 1955.

After his high school graduation, Mr. Bradley moved with his family to Los Angeles, California. There he worked in a variety of occupations while periodically continuing his education. He worked as a launderer, clerk, postal carrier for the United States Postal Service and as a Deputy Sheriff with the Los Angeles County Sheriff's Department. During this time he attended college classes at Los Angeles Community College and Compton College. In 1970, he left the Sheriff's Department to attend Pepperdine University in Malibu, California and to work for the Governor of California, Ronald Reagan, as assistant for community affairs. He graduated in 1973 with a B.S. degree. He continued his work for Governor Reagan through the end of 1975.

After leaving the Governor's Office, Bradley worked as director of public relations for the Charles R. Drew Postgraduate Medical School of Los Angeles from 1975-1977. He served as assistant to the vice president and account executive with United Airlines in 1977-1981. Mr. Bradley was a staff member of the Office of the President-Elect serving as special adviser to the director of the office of Presidential personnel.

From the beginning of the administration, Mr. Bradley was a Senior Policy Adviser within the Office of Policy Development staff, focusing on urban affairs and small business. He continued, on an ad hoc basis, as an adviser to Presidential Personnel on minority appointments.

Mr. Bradley was promoted in April 1982 to a Special Assistant to the President for Policy Development. He was transferred at this time from the payroll of the Office of Policy Development to the Counsellor to the President (Edwin Meese) payroll. This assured Bradley was not covered by the Hatch Act and could participate actively in the 1982 mid-term elections. At the time, his primary responsibilities were working with the Office of Policy Development staff to assure that policy analyses for the President were sensitive to the needs and priorities of the minority and disadvantaged communities. In August 1983, Counsellor to the President, Edwin Meese, authorized a "temporary" transfer of Mr. Bradley to the White House staff working in the Office of Public Liaison. He retained his title of Special Assistant to the President for Policy Development. For some time he had been operating as an independent public liaison with the black community and this move formalized that function. His move was made permanent in 1986 although he retained his office space with the Policy Development Office throughout his time at the White House. He also continued his advisory role on minority appointments. Bradley remained with Public Liaison until he resigned in early February 1989.

Mr. Bradley is married to the former Ruth Ann Terry and they have four children.

Scope and Content Note

The Melvin L. Bradley collections are unique at the Library. His long association with President Reagan, Edwin Meese, and other former members of Governor Reagan's staff allowed Bradley to carve out an area of expertise that only he handled. This included commenting and advising on policy issues regarding African-Americans and other minorities. In addition, Bradley was heavily involved with recruitment, assignment, and vetting of minority candidates for appointments within the Reagan administration. Bradley also acted as a public liaison between minority groups and businesses needing assistance in dealing with the Reagan Administration or looking for possible work contracts. The Library had to make some careful decisions on what material was placed with the Office of Policy Development, but it is important to understand these multiple functions of Bradley made it hard to say that any one White House Office was his actual "home."

White House records show that Bradley was moved from the Office of Policy Development payroll in 1983 and he was placed on the White House payroll. This action was a request from Counselor to the President Edwin Meese, allowing Bradley to participate in political events. The Hatch Act had barred him from this activity while on the Office of Policy Development payroll. Meese also stipulated that Melvin Bradley could return to his Office of Policy Development slot after the 1984 election. This never happened. Beginning in late 1983, Bradley was on the Office of Public Liaison payroll and reported to the President through the head of this office. In May 1986 Bradley was physically moved to the Office of Public Liaison offices and his support staff was moved over to the Office of Policy Development and payroll. His title remained Special Assistant to the President for Policy Development and this never changed throughout his tenure at the White House.

The filing system used by Bradley's office was also unique. There are multiple and over lapping folders of the same material, especially in the Correspondence series. Bradley's office used a coding system for correspondence. The Library has not found any explanation of this coding system. One of the overlapping folders was general correspondence for 1983 and this material was all moved to the Office of Public Liaison collection.

For general subject files, Bradley's office used an alpha-numeric coding system for folders, A-1, A-2, A-3, etc. Other filing systems found in his collection did not always have this designation. The Library has tried to retain original filing for this collection, but this was not always possible. We have placed subject files within the Public Liaison collection only if there is clear evidence that Bradley was using the folders and adding material past his transition date to Public Liaison, August 1983.

All material on minority recruiting and placement has been placed in the Office of Public Liaison to maintain continuity.
