Biography

Biography

T. Kenneth Cribb, Jr. served President Ronald Reagan for almost the entire Administration in the Office of Cabinet Affairs, the Office of the Counselor to the President and the Office of Domestic Affairs.

Born in 1948, T. Kenneth Cribb, Jr., is a native of South Carolina. He received a B.A. from Washington and Lee University and a J.D. from the University of Virginia School of Law.

Cribb graduated in 1970 from Washington and Lee University and took his first job as national director of the Intercollegiate Studies Institute (ISI) from 1971 to 1977. ISI is an adjunct educational organization dedicated to promoting the teaching of core American and Western values or "educating for liberty," as their mission states. He left ISI to complete his law degree at UVA, graduating in 1980. During that year he also served as deputy to the chief counsel of the Reagan campaign.

In the Reagan White House, Chief of Staff James Baker, Counsellor to the President Edwin Meese III, and Deputy Chief of Staff Michael K. Deaver formed a senior staff triumvirate which came to be called "the Troika. Meese's responsibilities included the overseeing of relations between the White House and the Cabinet; organizing and running the cabinet council system of government Reagan preferred and overview of policy, planning, strategy and for the first year of the administration national security policy. Meese had a small, loosely organized staff to assist him in these functions.

Cribb began working in the Office of the Counsellor in 1981, focusing on cabinet affairs. Early in the Administration this sub-office was established as its own entity and Cribb became the first Director of the Office of Cabinet Affairs. In 1982, he returned to the Office of the Counselor to work directly for Ed Meese as an Assistant Counselor to the President. When Meese left the White House in 1985 to become Attorney General, Cribb followed him to the Department of Justice as "Counselor to the Attorney General."

Cribb left the Department of Justice in late 1986 and worked briefly on Wall Street as an attorney. He was recruited back to the Reagan Administration in early 1987 to be Assistant to the President for Domestic Affairs and the Director of the Office of Domestic Affairs.

In 1984, President Reagan appointed Cribb to the Board of Governors for the American Red Cross. He served two three-year terms while simultaneously working for the White House and the Department of Justice.

Cribb has a long and varied association with conservative organizations and promotion of conservative education since leaving the White House. He served as President of ISI from 1989-2011, and served on its board until May 2012. During his tenure, ISI expanded its educational programs. He served as vice chairman of the Fulbright Foreign Scholarship Board from 1989 to 1992.

Cribb was president of the Collegiate Network, an association of alternative college newspapers; president of the Council for National Policy, a conservative umbrella organization; member of the Board of Advisors for the Foundation for Individual Rights in Education; is counselor to the Federalist Society for Law and Public Policy, a conservative legal organization. Cribb also serves on the Board of Advisors of the Russell Kirk Center for Cultural Renewal, an educational organization that continues the intellectual legacy of noted conservative icon Russell Kirk, and on the Board of Visitors of <u>Ralston College</u>, a start-up liberal-arts college in Savannah. He served as President of the Philadelphia Society.

Cribb has been published in the National Review, The American Spectator, The Intercollegiate Review, Modern Age, and Human Events.

Scope and Content Note

This collection was arranged in 1993 and re-arranged in 2015. It consists of a wide variety of series reflecting Cribb's responsibilities within the White House supervising four offices and his responsibilities for specific projects such as the Reagan Legacy and the Economic Bill of Rights. His personal material as a Governor of the American Red Cross is also included although technically this material is a federal record.

The Library notes the files from the Office of Domestic Affairs were not filed in any particular organized fashion. Care was not given to foldering like-minded material

together and much material is often misfiled. The Library has attempted to correct some more obvious errors in filing without changing the nature or character of these collections.

This series consists of material related to domestic issues. Topics include congressional testimony regarding corporate takeovers, South African divestment statutes, press conference preparations, regulatory programs in the federal government, racial criteria in federal contracts, and World Cup 1994 applications. This series also includes speech drafts and daily reports to the White House Chief of Staff. This material is arranged alphabetically by folder title.

SERIES II: DOMESTIC POLICY COUNCIL

This series consists of agendas, background paperwork, and meeting minutes related to the Domestic Policy Council meetings. Topics include AIDS, acid rain, and nuclear power. This material is arranged chronologically by folder title.

SERIES III: ECONOMIC POLICY COUNCIL

This series consists of agendas, background paperwork, and participant lists for the Economic Policy Council meetings. This series consists of material related to several events and meetings Mr. Cribb or the President attended. Material includes invitations to speaking engagements, biographies of White House staff members, speech transcripts, and schedule proposals. This material is arranged alphabetically by folder title.

SERIES V: NATIONAL DRUG POLICY BOARD

This series consists of material related to federal drug programs. Topics include the Interdiction Committee, investigations, prosecutions, prevention, and health. This material is arranged chronologically by folder title.

SERIES VI: TASK FORCE ON REGULATORY RELIEF

This series consists of material related to regulatory relief. Topics include the federal tax system, alternative fuels, drug initiatives, and air quality. This material is arranged alphabetically by folder title.

SERIES VII: JUDICIAL SELECTION

This series consists of material related to federal judicial selections. Topics include the Bork and Kennedy Supreme Court nominations, open circuits and districts, and backgrounds of nominees. This material is arranged chronologically and then alphabetically by folder title.

SERIES VIII: WHITE HOUSE STAFFING MEMORANDA

This series consists of material related to issues needing White House staff input, comments, or editing. Issues include energy security, Conference on Drug-Free America, and proposed Executive Orders. This series also includes talking points, and letters of commendation. This material is arranged alphabetically by folder title.

SERIES IX: PRESIDENT'S WEEKLY UPDATES

This series consists of material related to the weekly update on all issues prepared by the various White House offices, including the Press, Legislative, Policy Development, Cabinet Affairs Offices and the Office of Management and Budget. Topics covered include AIDS, the federal budget, the space station, arms control; the free trade agreement with Canada and other domestic issues. This material is arranged chronologically by folder title.

SERIES X: BUDGET DIRECTOR REVIEWS

This series consists of material related to budgets for various federal departments. Issues include loan asset sales, credit vouchers, and loan servicing. This material is arranged alphabetically by folder title.

SERIES XI: ECONOMIC BILL OF RIGHTS 1987

This series consists of material related to the President's efforts at enacting an "economic bill of rights (EBOR)." On July 3, 1987, President Reagan gave a speech proposing the enactment of an Economic Bill of Rights guaranteeing four fundamental freedoms: the freedom to work, the freedom to enjoy the fruits of one's labor, the freedom to own and control one's property and the freedom to participate in a free market. His speech included specific plans of action to achieve this new bill of rights. This series contains material relating the implementation of this effort and includes drafts of this speech and implementing measures; weekly reports to the president, Heritage Foundation newsletters, and suggested budget reforms. This material is arranged alphabetically by folder title.

SERIES XII: THE REAGAN LEGACY

This series consists of material related to the Reagan presidency and its legacy. Material is related to assessments of the management style of the president, White House staff members, White House transition between administrations, and various domestic and foreign policies. This material is arranged alphabetically by folder title.
