Biography

Biography

Dr. Michael Guhin was put on special detail from the Department of State to the National Security Council in May 1981. While at the NSC, Dr. Guhin was Director of Global Issues, including U.S. non-proliferation policy; international nuclear energy affairs, Law of the Sea (LOS), seabeds, and fisheries; international environmental, pollution, and narcotics matters; refugees and immigration; United Nations political affairs; and polar affairs.

Dr. Guhin served as Director of the Office of Non-Proliferation and Export Policy in the Department of State from 1978 until his assignment to the NSC. From 1976 to 1978, he served as Assistant Director for Export-Import and International Safeguards at the Nuclear Regulatory Commission. He served as a member of the NSC staff, from 1969 through 1975, during the Nixon and Ford administrations, dealing with international nuclear and arms controls affairs. In 1975 Dr. Guhin was on leave as a Council Research Fellow at the Washington Center for Foreign Policy Research (John Hopkins School of Advanced International Studies), in conjunction with a project at the American Enterprise Institute.

Dr. Guhin earned a B.A. (*summa cum Laude*) in political science from the University of Southern California in 1962. He received an M.A. in political science from the University of Southern California in 1964. In 1967, he received a PhD in international politics from the London School of Economics and Political Science. Dr. Guhin wrote *John Foster Dulles: A Statesman and His Times*, published by Columbia University Press in 1972. He has written numerous articles on U.S. foreign affairs matters, including a monograph *Nuclear Paradox: Security Risks of the Peaceful Atom*, published by the American Enterprise Institute in 1976.
