Scope Note

On November 25, 1986, President Reagan announced he was appointing a "special review board" to conduct a comprehensive review of the role and procedures of the National Security Council (NSC) staff in the conduct of foreign and national security policy. The discovery of the NSC's involvement and direction of the efforts to trade arms with Iran for the release of hostages held in Lebanon, and the subsequent diversion of some of the funds acquired from the arms sale to the U.S. backed anti-Nicaragua Sandinistas fighters ("Contras') prompted this review. These actions were known as the Iran-Contra Affair. On November 26, 1986, Reagan announced he was appointing former Senator John Tower, former Secretary of State Edmund Muskie, and former National Security Adviser Brent Scowcroft to serve as members of the Special Review Board. Senator Tower served as the chairman of this Board, thus it became known as "The Tower Board."

The Board was specifically asked to review the NSC staff's proper role in operational activities, especially extremely sensitive diplomatic, military, and intelligence missions. They were also asked to review the implementation of the President's foreign policies by the NSC.
