Biography

Charles Dean McGrath is a government and private practice attorney. He has worked in multiple presidential Administrations.

C. Dean McGrath was born May 2, 1953 in Chicago, IL and was raised in Grand Island, NE. He graduated from Grand Island High School where he was honored in 2005 in the Grand Island Senior High School Hall of Honor. He is a graduate of Duke University (B.A. with distinction in economics, 1975). He is an Honored Graduate of the University of Nebraska College of Law 100th Anniversary (1991). McGrath received his J.D. from the University of Nebraska College of Law in 1978. He also attended the National War College (1985).

Mr. McGrath began his career in public service as an attorney-advisor, Office of the General Counsel, Department of the Treasury. In 1981, McGrath was a Special Assistant U.S. Attorney, U.S. Attorney's Office, District of Columbia.

McGrath began his first stint at the White House as an Associate Counsel to President Reagan from 1986 through the end of the Administration. For part of 1989, McGrath was a special counsel for the Department of Defense. He then was Acting General Counsel, Deputy General Counsel and Associate General Counsel for the Department of Transportation from 1989-1991.

McGrath then served as Counsel to the Director and General Counsel of the Peace Corps of the United States, 1991-1992.

In August 1982, McGrath was appointed Deputy Assistant to the President and Deputy Staff Secretary in the George H.W. Bush Administration.

Leaving public service at the end of the George H.W. Bush Administration, McGrath was senior attorney for the American Automobile Manufacturers Association from 1993 to 1996.

In 1996, a former Reagan Administration White House Counsel associate, now Representative Christopher Cox (R-CA), asked McGrath to be his Chief of Staff and Chief Counsel. At this time Cox was heavily involved in the question of Chinese infiltration and spying on U.S. military and technical information. McGrath became the Staff Director for the U.S. House of Representatives Select Committee on U.S. National Security and Military/Commercial Concerns with the People's Republic of China, 1998-1999. McGrath remained with Cox from 1996-2000.

In January 2001, Vice President Dick Cheney announced that McGrath would be returning to the White House as Deputy Chief of Staff to the newly-elected Vice President. McGrath remained in this position until the end of 2005.

McGrath is an adjunct professor of law at Georgetown University Law Center, where he teaches a seminar on the constitutional aspects of foreign affairs.

McGrath is currently an Attorney-at-Law with McGrath & Associates in Washington, D.C. He is also Of Counsel, Gross & Welch, P.C., L.L.O. He was previously a partner with Manatt, Phelps & Phillips, L.L.P. HIs law practice specializes in federal government relations and litigation.

He is married to a former Reagan White House Associate Counsel, Patricia Bryan. They have three children and reside in Alexandria, VA.
